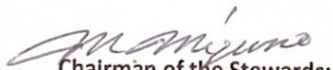

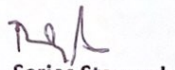

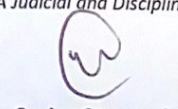
**Offence** Failure to respect proper track limits
